The King's Summer School Fees & Refunds Policy

Summer School fees

Our fees will always be clearly listed in our prospectus and on our website at <https://thekingssummerschool.co.uk/>

A student enrolment on the King's Summer School is not confirmed unless you have fully completed the online registration process, a deposit of £500 GBP (or full fees) has been received, and it has been acknowledged in writing by the King's Summer School team.

Please note that the deposit is non-refundable and is part of the full fee, and not an additional cost.

Full payment of all fees must be received no later than 01 June 2026. If full payment is not received by this date, we reserve the right to cancel the student's place, and the deposit payment will be forfeited. If an application is made and accepted after 01 June 2025, full payment of fees must be made at the time of the booking.

All payments of Fees must be made in pounds sterling (GBP) and are inclusive of any taxes or bank fees where applicable.

Impromptu expenses

The King's Summer School shall not be obliged to make payments for impromptu expenses (such as doctor's fees) on behalf of the Student or the Parent. Where such payments are required, the Parent agrees for appropriate payments to be covered by the student. Should funds be insufficient or unavailable, the Parent shall make payment in advance by card or bank transfer.

Cancellation

- Permanent withdrawal - If you wish to permanently withdraw the student from the summer school, you must notify us in writing with as much notice as possible.
- Early departure – If you decide to withdraw the student from the Summer School, or if the student withdraws him/herself during the delivery dates, and prior to the departure date shown on the confirmation of registration documents, they may do so on the understanding that no refund of fees paid will be made, save in exceptional circumstances.

- Exclusion – If the King's Summer School decide to send a student home before the end of the programme, which may be because of (but not limited to) incorrect or misleading information provided at registration, or student behaviour and breach of our 'Student Behaviour & Rules Policy', no refund of fees paid will be made, save in exceptional circumstances.

In all cases, should transportation (such as an airport transfer) be necessary, we will require a minimum notice period of 24 hours which takes effect from the time we receive written notification. Transportation may incur an additional cost, which is payable by the parents in advance.

Please refer to the 'Refunds' section of this 'Fees & Refunds Policy' for more details on how withdrawing may impact your fees payments.

Refunds

For cancellations before your course start date, the remainder of the course fees less the deposit amount will be proportionally refunded as per the table below:

Period Before Start Date	Total Refunded
120+ days	100%
90-199 days	50%
45-89 days	25%
0-44 days	0%

Cancellations after the start date of the course for any reason will receive no refund of any course fees.

If incorrect information or misinformation is provided at registration to the King's Summer School, we reserve the right to ask the student to leave the course. In this case, there will be no refund of the course fees.

Under exceptional circumstances, which may include but is not limited to: (a) a serious breach of our 'Terms and Conditions' by the School, (b) cases of serious illness or genuine hardship (c) student visa refusal, any refund is given at the sole discretion of the Summer School and Commercial Director.

All refunds are made in pounds sterling. We cannot refund any shortfalls due to exchange rate fluctuations or offer compensation for any bank or other charges that may be incurred.
